#### **6.2 Executive Director's Report: David Tayler (BIA Executive Director)**

- Gave presentation verbally and on-screen
- Reviewed events, marketing efforts and beautification projects in 2024
- Highlighted philosophy/strategy for 2025

#### **6.3 Treasurer's Report: Approval of 2023 Financial Statements & 2025 Operating Budget:** (Presented by D. Tayler)

- The Audited Financial Statements for the calendar year 2023 were presented as approved by the BIA Board. Motion to receive the 2023 Audited Financial Statements made by Dave Maculius, seconded by Noelle Smith. No opposition, MOTION CARRIED.
- The 2024 Operating Budget was presented as approved by the BIA Board. Noted highlights included at 2% levy increase, use of reserves, funding expectations/uncertainty and contingencies, increased general advertising spend, and new addition of numerous smaller events. Motion to receive and approve the 2025 Operating Budget made by Dave Maculius, seconded by Lyndsay McAlpine. No opposition, MOTION CARRIED.

#### **7. Guest Speaker: Cristina Geissler, City of Hamilton Business Development and BIA Officer**

- Cristina Geisler from the City of Hamilton, Economic Development provided information on some of the City's small business incentive programs available to business - plus general support available from City's Economic Development team. Also reminded the members that nominations for the Board of Management happen during municipal election years every four years (next in 2026).

#### **8. Other Business**

- General Security: Some discussion around personal safety, specifically regarding aggressive "panhandling". General reminder about reporting each and every security or safety issue to appropriate authorities - to encourage proper data tracking and responses. Suggestion of a "buddy system" to share concerns and increase communication
- Cactus Festival: Continued concerns around vendors, competitors, cleanliness etc., during the event. Board notes they are actively working towards a better relationship with the Cactus committee on these very items.
- Call for Volunteers: general reminder to BIA members that input is needed, welcomed and encouraged on the various sub-committees.
